PNWA Executive Director Kristin Meira testifies at House Transportation & Infrastructure Hearing

Pacific Northwest Waterways Association (PNWA) Executive Director Kristin Meira testified today before the U.S. House Transportation & Infrastructure Committee. The Committee held the first hearing of the 116th Congress entitled "The Cost of Doing Nothing: Why investing in our Nation's Infrastructure Cannot Wait" to discuss necessary federal investment in America's infrastructure.

Meira highlighted the infrastructure needs of ports and navigation in her testimony. Ports are critical economic drivers for their local communities and for the nation. Many modes of transportation come together at our nation's ports to provide efficient and safe movement of both commercial cargo and people. Infrastructure investment at ports is critical for a strong U.S. economy.

"Transportation is not a partisan issue, it's about moving people and goods more efficiently in this country and connecting us to the world," said Transportation and Infrastructure Committee Chairman Peter DeFazio (D-OR).
